Whereas **Department of Chemical Engineering, College of Engineering & Technology, Bambhori, Jalgaon** and **V. B. Engineers, Nashik.**, being the premier departments in addition to education & training in engineering sciences, desire to promote consultancy & research activities in various engineering disciplines such as – **Chemical Engineering & Allied Branches of Chemical Engineering**. These activities are proposed to be facilitated through mutual interaction between the Departments, & whereas both the Department and Industry desire to enter into collaborative activities with prime vision of overall development of Industries, Faculties & Students in particular & society at large, & whereas, in order to achieve the above Vision, it is proposed to have a mission to promote consultancy & research work in various thrust areas such as design & development in various fields, etc. & whereas the following long terms & short terms goals are indentified for this purpose.

## **Long Term goals:**

- i. Product / Process development, patenting & vendor development.
- ii. Quality Improvement Programs leading to research & development of faculty members.

### Short Term goals:

- i. Dissemination of information in the thrust areas through seminars, workshops, specialized courses, invited talks etc.
- ii. Up gradation of infrastructure & knowledge/skills of faculty.
- iii. Internship and Industrial Visit to students of the Chemical Engineering Department.
- iv. Arranging joint socio-economic development programs.
- v. Placement to students of the Chemical Engineering Department.

It is, therefore, now agreed upon by & between the Department and V. B. Engineers as under.

### 1. Scope :

This MoU contains, terms & conditions for the Involvement of the **Department of Chemical Engineering, College of Engineering & Technology, Bambhori, Jalgaon and V. B. Engineers, Nashik** on the mutually agreed basis in the implementation of various joint projects.

### 2. Responsibilities :

- i. Providing necessary faculty support for the conduction of such activities.
- ii. Providing infrastructure to the faculty and students at V. B. Engineers for research and other activities.
- iii. Committing & providing active help, cooperation & dedicated involvement of the authorities & faculty members of the **Department of Chemical Engineering, College of Engineering & Technology, Bambhori, Jalgaon and V. B. Engineers, Nashik**, in the realization of the mission.
- iv. Active involvement in long terms needs & objectives.
- v. Both parties acknowledge that this collaboration is based on an enduring relationship between the two parties rather than for immediate benefit & hence they hereby commit themselves to devote & dedicate their wholehearted support & commitment to accomplish the objectives in an agreed manner & within an agreed time frame as per the validity.
- vi. Both parties agreed to set up a steering committee under the co-chairmanship of **HOD, Chemical Engineering** & Proprietor of Industry, compassing the representative of both institutions on an agreed basis to oversee & monitor the activities under this MoU & devise corrective steps, if & when necessary or even modify the modalities if so warranted by the circumstances.

### 3. Validity :

This MoU shall remain in force for a period of three years from the date of its being entered into. It may further be extended for such a period & on such terms as may be agreed upon by both the Institution.

#### 4. Termination of the MoU :

This MoU will stand terminated if,

- i. Either of the parties is rendered helpless or inactive by legal process or by circumstances beyond its control.
- ii. Either party decides to opt out for compelling reasons by giving a notice of three months to the other party indicating in writing the reasons therefore.
- iii. The goals under MoU are accomplished.

#### 5. Effects of Termination :

In the event of the termination of this MoU, either party shall:

- i. Return to the other Department of the Institution any equipment or material which may be on loan with it from the other institution.
- ii. Settle any outstanding dues without recourse to compelling action.
- iii. Complete the ongoing projects to the extent possible to avoid major inconvenience or serious dislocation of the work of either Party.

2. V. B. Engineers, Nashik.

#### 7. Interpretation and Dispute :


Any dispute or doubts as to the interpretation of the clauses here in the letter & spirit of the methodology shall be mutually discussed & settled by the HOD & Proprietor & their decision in the matter shall be final & binding on both parties.

#### 8. Force majeure :

The slandered force majeure clause will apply & the party affected by the clause, which is unable to render service, shall intimate the other party about the reason & indicate the likely date when it would be in a position to render service.
