- The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research. C) . Both Parties, being legal entities in themselves desire to sign this MoU for

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- The term of Definitive Documents shall be mutually decided between the 1.4 Parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MOU

- The budding graduates from the institutions could play a key role in 2.1 technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- Industrial Training & Visits: Industry and Institution interaction will give 2.2 . an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs

for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working

- Internships and Placement of Students: Second Party will actively engage to help the delivery of the Internship and placement of students of 2.3 the First Party into internships/jobs, as per AICTE internship Policy. The Second Party will also register itself on AICTE Internship Policy Portal for disseminating the Internship opportunities available with them.
- Guest Lectures: Second Party to extend the necessary support to deliver guest lecture to the students of the First Party on the technology trends and 2.4 in house requirements.
- Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the 2.5 terms specified herein.
- There is no financial commitment on the part of the SSBT's College of Engineering & Technology, Bambhori, Jalgaon-425001 (M.S.), the First 2.6 Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3: INTELLECTUAL PROPERTY

Nothing contained in this MoU shall, by express grant, implication, estoppels or otherwise, create in either Party any right, title, interest, or 3.1 license in or to the intellectual property (including but not limited to knowhow, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4: VALIDITY

This MOU shall be valid for 3 years' from the date 11/04/2023 and each party 4.1 shall be at full liberty to terminate the collaboration with mutual consent.



CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES It is expressly agreed that First Party and Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
