CLAUSE 1: CO-OPERATION

CLAUSE 2: SCOPE OF THE MoU

- Both Parties to obtain all internal approvals, consents, permissions, and licenses of 2.9 whatsoever nature required for offering the Programs on the terms specified herein.
- There is no financial commitment on the part of either SSBT's College of 2.10 Engineering & Technology, Bambhori, Jalgaon-425001 (M.S.) or Prolific Training Centre, Thane (W). If there is any financial consideration, it will be dealt separately and agreements, if any, will be made in writing by mutual consent.

CLAUSE 3: INTELLECTUAL PROPERTY

Nothing contained in this MoU shall, by express grant, implication, estoppels or 3.1 otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4: VALIDITY

- MoU will be valid for TWO YEARS 4.1
- This Agreement will be valid until it is expressly terminated by either Party on 4.2 mutually agreed terms, during which period National Infotech, 202, 2nd Floor, A-19/20, Road No.9, Udhyognagar, Udhana, Surat-394210, Gujarat, the Second Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of National Infotech, 202, 2nd Floor, A-19/20, Road No.9, Udhyognagar, Udhana, Surat-394210, Gujarat, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MoU
- Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In 4.3 the event of Termination, both parties have to discharge their obligations

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that First Party and Second Party are acting under this MoU 5.1 as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other
